These unauthorized replicas infringe upon our intellectual property rights, violate U.S. patent law, and pose significant safety and liability risks to end users. The “Wing Duckhead” is a machine component, designed for use with tire-changing equipment, manufactured and patented by Nexion S.p.A..

Nexion S.p.A. manufactures products not only for its own Corghi brand but also for various other brands, including those wholly owned by Nexion S.p.A. as well as other well-known brands outside the Nexion group. Therefore, any “Wing Duckhead” product with the design below, shown in our patent, no matter what piece of equipment or brand, legally needs to be a genuine Nexion product containing the patent markings as shown below. The importation of these patent-protected products is very limited, with Corghi USA being one of a couple authorized sources.

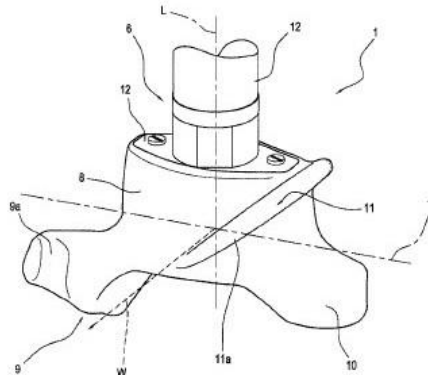
